'We aim to bust myths about will-writing'

Jatin Popat (below), CEO and founder of Willjini. com — a year-old succession services portal that offers will-writing services and other succession services — discusses why such offerings are gaining ground in India.

How would you define the need for a service such as Willjini. com?

The website was launched in June 2014, to allow people to make wills from the comfort of their homes. Indians are not comfortable with addressing the idea of death. A lot of people, at some point, consider making wills but don't end up doing so, thinking the

legal process will take long, and procrastinate until its too late. It is crucial to have a will to avoid disasters in the future.

Willjini. com facilitates the writing of a will in 30 minutes, and customers do not have to physically meet

anyone or make incessant calls. Only your witnesses will know about your will. The portal is managed by succession services lawyers.

Can you run us through the online process?

You must fulfil three steps
— first, fill in your personal
and property details; next, file
your distribution wishes; and
finally, declare your will. Once
all details are filled in, the will
is sent to you in a Word document.

To generate a will instantly, you need to fill in details of witnesses and include the signatures of two witnesses.

What are the advantages of an online will?

The greatest advantage is that there is a fixed price to making your will. A lawyer may charge anywhere between a few hundreds to a several thousands. For a fee of Rs 5,000.

exceptions such as remarriages, adopted children and various communities, instead of having to look for specific lawyers for a certain kind of will.

How important is it to make a will?

There should be at least one will per house. The absence of a will can cause confusion over distribution of property, and a will could thus prevent disputes between siblings or successors.

Why let the government decide what a successor will receive by way of inheritance, when the family member can use his or her own discretion?

How popular are online wills in India?

The concept was introduced about 20 years ago, in countries such as the US, UK, Australia and Canada. In India, it is about a year old. It is important that people know how the process works with online wills since there are a lot of misconceptions involved.

For instance, people believe that at 35, they don't need a will. If you can buy life insurance policy, you should also have a plan to protect your family in case anything happens. Also, NRIs mix their Indian assets with their foreign wills instead of making a separate will as per Indian laws.

Radhakrishnan. 25, an IT professional, was about to buy her first flat in Guduvancheri, Chennai, in July this year, and was looking for guidance. "I am not wellversed with legal rules regarding purchase of a property."

She logged on to Meeturpro. com, an e-commerce platform for professional services such as personal taxation, business set up, drafting deeds and agreements, and after sharing details about the developer, title, and the flat online, she got help with her sale agreement, verification and background checks.

This service cost her Rs 11,000, excluding taxes, and two months ago, she bought the 2BHK flat.

Similarly software engineer Prince Gupta, 26, preferred to renew his rental agreement five months ago through the two-year-old portal Legaldesk. in. This, he says, helped him save on time and the inconvenience caused, if brokers were involved in the process.

LegalDesk.in is a do-it-yourself platform that helps users make agreements, deeds, affidavits and wills online from any where, anytime. "I found the online service very professional and transparent," says Gupta. "I could see the entire process right in front of me, and I got

my agreement within four days. without having to make a single visit to their office."

Likewise, Legaliini com that provides on-demand legal services, helped Juhu resident Paras Mistry 40, prepare his sale agreement to convert rent ed property into ownership and complete the sales transaction, including registration. "It was great to have an online, professional expert helping me sort out complex real-estate issues, says Mistry

Across the country a growing number of people are opting for online legal help to verify

documents and make wills. as against consulting offline brokers or lawyers. Experts say. online portals can help clients save time, and exorbitant fees paid to lawyers.

"Accessing legal help online is a great start. It helps digitise all your documents and a website may inform a client about many other things that one may not get out of consulting a lawyer personally," says Pankaj Kapoor, director of real estate research agency, Liases Foras, "Also, for chores such as registering a sale deed for which agents charge Rs 5,000, you may end up paying less and actually get it on time.

HOW IT WORKS

According to Krupesh Bhat, 39, founder of year-old portal legaldesk.in, three main factors have led to a change in the mindset of people who were earlier suspicious of sharing legal details online and depended on brokers and lawyers to do it for them. "First, online services are more affordable, for instance, some of our services start at Rs 250," he says. "Also, we ensure that most requests are sorted within three days, which is not the case at all offline vendors."

Offline, the processes typically take more time, mainly because of unavailability of lawyers, the time taken for ntments to materialise and the hierarchy a documentation process has to go through. Therefore, it can take

a minimum of six to seven as any offline document. days for a document to be handed over to a client, and clients end up paying on a per-

Adds Vijayasarathy, "The final cost to the consumer in case of legal assistance is ually less online," he says. For example, a basic tax planning service costs Rs 376 and takes 24 hours online, but the same costs Rs 2,000, and can take about four days offline. says Vijayasarathy. He says his firm handles about 280 to 300 transactions a week, and caters to about 700 to 800 cus tomers a month, of which 30% are repeat customers.

At Legaldesk in, the most

common requests pertain to calculation of stamp duty, notarisation and registration of documents.

While Legaldesk in has a 20-member team, comprising four senior lawyers. Meeturpro.com's 28-member team consists of lawyers, chartered accountants, company secretaries, certified financial planners and cost accountants.

WHERE THERE'S A WILL

In addition to core realestate-related legal services. online firms also offer help with will-making. Williini. com is a Mumbai-based online provider of succession services and will-related dispute settlements, to Indians and NRIs with property in India. The yearold website offers FAQs on basic issues in 12 Indian languages and video assistance

Jayaben Nagda, 69, a home maker from Juhu, learned about online wills from her children "Running to and fro between lawyers was not feasible at my age. My two sons thought this was the best solution so I drafted my will online six months ago. It took me just an hour to make the will and I had help from lawyers all the time. I am also assured of having changes made as and when I want.

Similarly, Mumbai-based Ezeewill.com, launched in August 2014, is an online service of data submission for will preparation. At Ezeewill, for Rs 4,000, clients can draft up to two wills.

PROCEED WITH CAUTION

With the increase in online portals offering a range of technical and complex legal services, what are the precau tions customers must take to ensure they are not duped?

"Make sure the online com pany offers live support in case you need to talk to a legal expert on the telephone," says Bhat. "Check reviews of the

Users must also confirm that the price and the refund policy is clearly mentioned. "Reference checks are important. Users must read the fine print in the agreement and follow up with the website until they get the necessary documents in hand," says realestate lawyer Vinod Sampat.
